The cooler it is, the more I enjoy a good red. One rather chilly afternoon on the way back from a shopping trip, I stopped by Publix in search of my favorite Cabernet Sauvignon from "Josh". It is a nice bottle with a reasonable price. This particular Publix was out of my "Josh". So, perusing the wine isle, I came across a bottle of "Entwine" Cab which was marked down a couple of dollars. "Entwine" is the Food Network wine in several different varieties. I had not had one for many years, but I remembered it being very good. Being a sucker for a sale price, I brought it home. No disappointment here. It was smooth as silk and had a nice finish. I highly recommend it.

Recently, a friend who is quite knowledgeable about wine stopped by. Of course, a conversation ensued. He liked the article on wine glasses and felt it to be true, commenting that the proper glass does indeed make the wine taste better. While talking, he mentioned something I haven't written about for a long time. It has to do with tasting the wine properly. The first is the "Nose" or the smell of the wine in your glass. Swirl the wine gently and take in the aroma. See if you can detect the ingredients by the aroma. Oftentimes, the bottle will give you a hint of what to look for. This is particularly true with red wines. Then swirl the glass again and see if you see the "legs" running down to the bottom of the glass. The better the wine quality, the longer the legs. Try it and see if it adds to your tasting experience. Most of all, please drink responsibly and enjoy! Make 2020 your banner wine year!

The CWL Appliance Service is probably one of the best things about living in Coco Wood Lakes. The guys that put this group together really knew what they were doing. Back in 1985, nobody wanted to worry about fixing their appliances.

So Sy Friedman, Bruno Filippilli and their buddies, got together with about 240 of their like minded neighbors and using the power of group buying, got Broward Factory Service to bill them at a reduced rate.

After 34 years, Broward is still our service contractor and we continue to get lower prices and preferential treatment. That means we can call to report emergencies 24/7 knowing that it will be fixed within 24 hours.

Even better, there is no out of pocket costs for any service call. Whether you need an appliance fixed, or a electrical or plumbing repair, it's covered. We all heard stories about repairmen who charge \$75 or more, just to walk in the door. Our members pay nothing.

We may be incorporated, but we're not a business. We do not make a profit. We have no employees and we pay no salaries. We exist only to benefit the membership.

For the most part our members do not quit willingly. Some of the original 1985 members are still enrolled. They know that there is no individual service contract that even comes close.

Here's an example of what we're talking about. We just signed up a new member who had her own contract with Broward and was

paying \$743.75 for comparable coverage. Now she's paying \$325.

That's service for all her appliances and repairs for minor electric and plumbing. We also offer replacement allowances when new equipment is needed.

All members have an equal stake in the group's financial assets. Therefore, it is necessary for new members to achieve equity with the current members. A one time Initiation Fee of \$300 is required the first year.

For me, I couldn't imagine facing another day without the peace of mind I get from being a member. I enjoy the confidence it gives me to know that when things go wrong, one call will get them right.

I invite you to join. Get in on our current contract anytime at pro-rated fees. One less thing to worry about. Try it. You'll like it.

WHAT'S BEEN GOING ON?

Funny you should ask. We encourage you to read this entire article as it contains some very interesting facts. So sit down with your beverage of choice and let the read begin.

Beginning in early summer, the two auditorium AC units failed. They were very old. The Board directed its manager to seek out bids for replacements. In fact, three bids were received and reviewed. On a side note, board members are not required to have any specific knowledge but if a director has some special experience that is helpful, then that person is asked to oversee the project. Such was the case with the AC replacement. Unfortunately, the person who volunteered did not have the experience claimed. So the requirements for the new system neglected to include humidistats, which help to control the humidity. Again this occurred because the expected oversight was not provided. The intake vents installed were inadequate and the thermostats were incorrectly placed. This resulted in the Association having to contract for additional vents to be installed in the alcoves at each side of the auditorium and to have the thermostats moved. During inspection, the building inspector also noted that the finish work for the new openings was not completed. Again this occurred because no oversight was provided. Please note that our Association Manager is not versed in AC work, nor is required to be, but did provide detailed information as the work progressed.

The Board then moved on to the flooring project. Again multiple bids were obtained and one selected. Now, the clubhouse is some forty (40) years old and is actually two permanent buildings connected by the lobby. This info was obtained from reviewing the original blueprints. When the old red tile was removed, it was discovered that the lobby subfloor was about 1.5 to 3 inches lower than the auditorium, hallway and adjacent floors. This necessitated drilling out the old mortar. Several cracks, that appeared to have happened during settling, were discovered and some minor water intrusion that resulted in drywall replacement. The Association engaged a licensed surveyor to examine the subfloor and measure the cracks. The result was that the cracks were not going to pose a problem to the new concrete floor that had to be laid to level out the lobby area. Another licensed contractor removed the damaged drywall, applied a sealant and replaced the drywall adding chair rail to the lobby area.

While all of this was going on, our "expert" board member felt that permits should have been obtained and began notifying the County that work was being done without permits. This is known because this board member has been circulating a letter received from the County and would only have had access to that if they were the original complainant. These (anonymous) complaints to the County delayed the installation of the new flooring. After many site visits, Palm Beach County determined that a permit was not necessary for the flooring and work progressed. The new floors look amazing and those of you who have visited the clubhouse have given very positive feedback. Stop by if you haven't already and see for yourself. We feel you will be impressed!

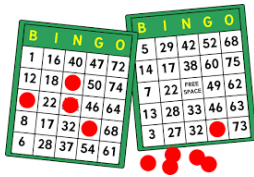
A permit for the lobby drywall was necessary because the replacement cost of \$1,395 was \$395 above the \$1,000 maximum for a "no permit required". At no time were any fines issued nor did the inspectors threaten the Association with fines as a result of the need for a permit. Please note, that when any work is undertaken, it is the vendor responsibility to advise the Board of Directors if permits are necessary. With all of the projects, the appropriate permits have been obtained and necessary inspections performed.

All of the work completed was funded from the Reserve account and the Clubhouse Improvement fund which is funded throughout the year via the budget. No special assessment has ever been needed for these improvements. Further, for fiscal year 2020, your quarterly maintenance payments were lowered by five dollars (\$5) per quarter.

Now while all of this was going on, our "expert" board member decided that our President was ineligible to serve due to a clause in the bylaws relating to time in residence (snow birds). Upon checking with our legal counsel, we were advised via attorney opinion, that current Florida Statutes Chapter 720 prevails and supersedes our bylaws. Unfortunately, this attack goes on to this day via emails and disruption during board meetings. It is also perceived that this board member disclosed information from a "closed confidential attorney meeting." This is supported by the fact that some of the information had been told back to the Association by our long time irritant resident.

In October, the Board of Directors adopted a fine schedule and created a Fining Committee in conjunction with our Rules and Regulations. What does this mean? Certainly **NOT** what you may have read in the recent tirade that came from the long-time irritant resident. The Board of Directors has the right to form rules and regulations in conjunction with the Declarations. Florida Statutes Chapter 720 permits fines under certain circumstances. The current set of Rules and Regulations, adopted in March 2019, has been reviewed, approved and recorded in the County by association counsel. **IT IS NOT THE INTENT** of the Board of Directors to fine anyone. These were established to aid the Board of Directors should the need arise. There is a process dictated by Statute that will be followed. If you have questions, please contact the office at 561-495-1133 and the concept of a Fine Committee and fines will be explained to you.

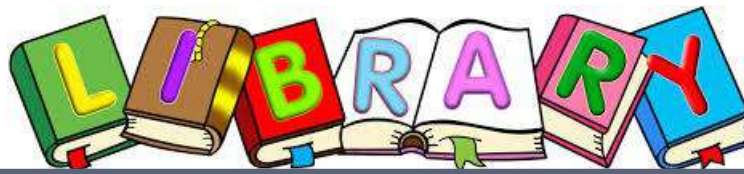

IMPORTANT NOTICE PLEASE READ

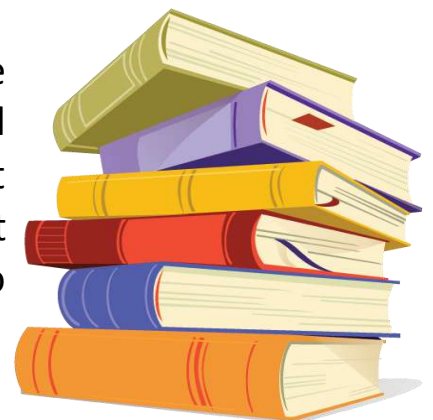
