CWL Reflections

For those of you who did not attend the March 21st Board Meeting, we had two different Electronic Voting companies share information with us on how the process works and what they had to offer. The Board tabled passing the resolution so they could do further research on this topic.

Although there are many benefits to electronic voting, homeowners are **not required** to use the system. You still have the choice to opt in or opt out. Of course we want you to use the system because the real benefit for Coco Wood Lakes will only come if the majority opt in. **an E-Voting site:**Why consider elections? can you derive from the system of the control of the contro

Here are some of the benefits to using electronic voting:

- We will save money on paper and mailing of the notices. The 2022 Election cost totaled at \$5,350.00. (The more homeowners we have who opt in, the less we will have to mail out).
- Yes, you can change your mind! Homeowners can opt in or out at anytime.
- The results are quick and reliable. It eliminates invalid ballots, choosing too many candidates, accidentally submitting two ballots, or not being

the designated voting member.

 Each resident will have their own access so they will be able to vote and receive a confirmation that their vote counted.

Here is a little clip of some information read on an E-Voting site:

Why consider electronic voting at all? Shouldn't you worry about security? How can any software handle secret elections? Isn't it more work? What benefits can you derive from electronic voting? It's just too new; you don't want to be the guinea pig!

Here's some good news - the technology issues of ecommerce have been resolved for decades and you aren't the first user of secure internet filing (in fact, Florida is not the first state to use electronic voting)!

The IRS settled the issues of secure income tax return filing years ago and even allows a taxpayer to sign with a PIN (Personal Identification Number). Today more than 90% of individual income tax returns are filed using safe, secure IRS eFile.

ACT NOW-Don't wait for a violation letter

Do you have a dirty roof, driveway or sidewalk? Clean it.

Is the paint on your home faded, stained or dirty? Paint it.

Letters are going to be sent out for these types of violations. Before you get one, please make arrangements to have these general maintenance items taken cared of. Lets keep our community beautiful!!

COMMUNITY SURVEY

Dear Members,

The Coco Wood Lakes Homeowners Association's (CWL) cable TV contract with Comcast will expire at the end of September 2025. When it expires, CWL will be spending \$50.50/month for each household for cable TV services (\$606/year/home). This represents about thirty percent of the entire HOA fee.

The Bulk Media Technology Committee (BMTC) is evaluating various options for what will happen when this contract ends. Preliminary research is starting now to ensure that any bulk contract vendor that may ultimately be selected by the Board to service the community, will have ample time to install any needed infrastructure improvements. We have begun information gathering and interviews with industry consultants and providers such as Comcast, AT&T, Blue Stream, Breezeline and Hotwire and are formulating a formal Request for Proposal which will be presented to each potential vendor.

To help the BMTC better understand and evaluate what is best for the community, all owners are being asked to complete a comprehensive survey detailing current use and future needs. There will also be a drawing for a valuable gift to one community member that completes the survey. This prize is on display in the Property Manager's office. The drawing will be held on Monday, May 1.

The way our community currently uses media and related technology and the way they might use it in the future, will be a major consideration in advising the Board of Directors accordingly.





<u>CWL Rules and Regulations</u>—Section 5: Landscape Maintenance and Watering. You are responsible for your own landscape maintenance which includes grass cutting and hedge and tree trimming. Trees and hedges must be trimmed so they do not obstruct sidewalks or street lighting. Trees and hedges should not cascade over the common area or encroach on the Palm Beach County right of way. Perimeter hedges (landscape buffer) along El Clair Ranch Road, Jog Road and S. Oriole Blvd. shall not exceed eight feet in height.


